**AGREEMENT OF CONFIDENTIALITY AND NON-DISCLOSURE FOR
STUDENT VISITS TO GOOGLE**

This Non-Disclosure Agreement ("Agreement") is made and entered into between Google Inc., for itself and its subsidiaries and affiliates ("Google"), and the participant as listed in the signature block below, for themselves and any school they may represent ("Participant").
